Well printed, properly bound bids presented in 2 copies one of which marked original, must reach **ADRA Rwanda's** Head Office located at the following address: **KG2 567 ST 14, Kacyiru sector, Gasabo District, Kigali City, PO Box 2 Kigali**, not later than **14<sup>th</sup> October, 2020 at 10:00 a.m.** late bids shall be rejected. The public opening will take place at **10h30 a.m.** on the same day.
3. The copies should be put in 'inner envelopes' having the name and address of the company. All copies should be put in other envelope called "outer envelope" marked with the reference number of tender notice with the following mentions :

7. A complete set of tender document in English may be obtained by the interested bidders at the same office, on presentation of the bank statement as a proof of payment of a no



8. Site visit is mandatory, and planned on **8<sup>th</sup> October, 2020 from 10 :00 a.m. To 14h00**
9. All bids must be accompanied by a Bid Security issued by a bank using the Bid Security Form included in the bidding document in the sum of : FRW 1, 500,000. The bid security shall be valid for a minimum of 30 days beyond the deadline of the extended validity period of the bid.
10. In case foreign companies participate in this tender, the local preference of 10% shall apply.
