The International Center for Research in Agroforestry (ICRAF) has *received a grant* from the African Development Bank to implement a project entitled: “*Promoting Climate Smart Agriculture for Improved Rural Livelihoods and Climate Resiliency in the Climate-Vulnerable Eastern Province of Rwanda Project*” and intends to apply part of the proceeds of the grant to facilitate payment for a contract for preparation of an Audit by a firm which will be based in Rwanda.

Interested consultants must provide information indicating that they are qualified to perform the services (**brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff**, etc.). Consultants may constitute joint ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank’s “Procurement Framework (2015)”, which is available on the Bank’s website at <http://www.afdb.org>.

Interested firms are invited to submit their Expression of Interest (EOI) along with relevant credentials/information indicating that they are available and qualified to perform the service. The firm must be registered and be in the approved list of auditors accredited by the **relevant Rwanda Accreditation Institute (Institute of Certified Public Accountants Rwanda/ICPAR)**. The firm must have a proven track record in accounting and financial auditing of development projects/programs, including those funded by donors.
