Bids shall be valid for 120 days

Please note that technical and financial proposals should be submitted in separate **sealed envelopes** written in **English**. Both envelopes should then be placed together in **one outer envelope**.

The financial proposal **must** be protected with a password and the password shall be kept by the bidder and provided to BRD only if invited to do so at the time of financial opening.

Do not open except in public session on 21st / 11 / 2025 at 10:00am local time
